

Using the IRS Data Retrieval Tool

The IRS Data Retrieval Tool automatically pulls your tax information from the IRS into your FAFSA. We highly recommend using the tool for a smoother financial aid process.

Why should you use the tool?

- Guarantees that the most accurate tax information is submitted.
- Reduces the chance of being asked to complete the verification process.
- If you are selected for verification, it's the easiest way to complete any "Tax Transcript" task.

Who can't use the tool?

- if you are married, but filed as 'single' or 'married-filing separately' for the requested tax year
- if you filed too recently (within 3 weeks of attempting to use the tool)
- if you filed a 1040X amended tax form
- if you filed a Puerto Rican or foreign tax return

Step-by-Step Instructions

These instructions assume that you have already submitted a FAFSA.

1. Log in to www.fafsa.gov with your FSA Username and Password.
2. Click 'Make FAFSA Corrections'.

7. If you are using the tool for both the student and the parent, you will have to complete this process twice. Once under the 'Student Financial Information' section and once under the 'Parent Financial Information' section before resubmitting the FAFSA.

8. Continue to the 'Sign & Submit' tab. Follow all of the instructions carefully to submit your FAFSA.
